#### RRBA Show Rules:

1. All rabbits must be permanently and legibly tattooed. All rabbits must be inside the showroom by 8:30am.
2. Judging will begin at 9:00a.m. For this to happen, please send payments with your entries.
3. Exhibitors are responsible for carrying their own animals to the judging tables; however, assistance will be available if requested.
4. All official ARBA show rules as of the date of each show will be in effect for these shows.
5. The show superintendent WILL remove any animal showing signs of illness. There will be no exceptions.
6. No refunds will be provided for scratched entries.
7. Returned checks will be subject to a \$50 charge to be paid prior to the exhibitor's show report being mailed. If the returned check is not made good in 30 days after notification by the show secretary, the exhibitor's entry will be removed from the show and amended reports will be sent to the appropriate national breed club secretaries.
8. There will be no changes to the show paperwork at the judges table without the consent of the show secretary. ARBA will be notified of exhibitors caught tampering with the show paperwork. That entry will be disqualified.
9. Breeds with less than ten rabbits will not be sanctioned next year unless sponsored.
10. No animal other than rabbits or animals assisting the handicapped are permitted in the showroom.
11. RRBA is not responsible for any loss due to fire, theft, flood, etc. All reasonable precautions will be taken to safeguard exhibitors and their animals.
12. **Woolled breeds** are to be groomed outside the showroom. No blowers or electric grooming equipment may be operated inside the showroom.
13. Substitutions made on the day of show must be ear number changes only.
14. Children are the responsibility of their parents – no screaming, shouting, or running is allowed in the showroom. Failure to control a child's behavior may be the basis for disqualification of an exhibitor's entire entry and forfeiture of all fees paid. Any property damage incurred will be the parents' responsibility.
15. RRBA reserves the right to add, cancel or substitute judges as necessary.
16. Best In Show and Reserve in Show will be chosen from all BOB winners in that show. It is the owner's responsibility to bring the BOB rabbits to the BIS judging table in a timely manner.
17. This is a carrier cage show. All carriers are required to have leak proof pans.
18. Rabbits entered in fur classes must also be shown in regular breed classes.
19. No one is permitted upstairs in the showroom.
20. **Chairs and grooming tables will only be allowed if space is available after all the carriers are in the showroom. Please stack your cages at least two high indoors to accommodate other exhibitors.**
21. IN THE CASE OF INCLEMENT WEATHER, THERE ARE NO REFUNDS IF OUR RABBIT SHOW IS NOT CANCELLED.
22. RRBA reserves the right to decline future entries if exhibitor has a history of entering and then failing to attend the show.;
23. Awards will be given if the breed is sanctioned and there are at least 10 rabbits shown.
24. The filing of an entry indicates acceptance of these rules.

#### Directions to the show:

**From the North or South:** I-95, US 1 or US 301 to VA Route 30 East (exit 98 off I-95). From I-95 or US 1, travel approx 11.5 miles past the entrance to King's Dominion. Mangohick Vol. Fire Dept. is on the left just before Rt. 644 on the left. (Your turn is approx 1 mile after the "Mangohick" highway sign.)

**From the East:** I-64 West to I-295 North to US 360 East. Travel approx 17.5 miles on 360 to Central Garage, left on VA Route 30 West approx 8.8 miles to Mangohick Vol. Fire Dept. on right, after the 2nd intersection with Rt. 644.  
ALTERNATIVE ROUTE VIA WEST POINT: I-64 West to VA Rt. 33 East to VA Rt. 30 West in West Point. Follow above directions from Central Garage (DO NOT TURN in Central Garage: stay on Rt. 30.)

**From the West:** I-64 East to I-295 North to I-95 North to Exit 98. Travel approx 11.5 miles past the entrance to King's Dominion. Mangohick Vol. Fire Dept. is on the left just before Rt. 644 on the left. (Your turn is approx 1 mile after the "Mangohick" highway sign.)
