# ARBA 2024 NATIONAL YOUTH CAVY MANAGEMENT CONTEST

#### **PURPOSE**

To acknowledge excellence of management style by ARBA youth members in the areas of housing & equipment, feeding & animal care, disease control, record keeping, breeding & genetics for the care and production of cavies.

#### **RULES**

- 1. Any ARBA youth member is eligible to compete. Membership must be valid on August 1st, 2024. Attendance at the ARBA National Convention is not necessary.
- 2. Management application is to be composed and completed by the contestant.
- 3. The two most popular (and readable) fonts are Times New Roman and Arial, using 10 or 12 point type.
- 4. Up to seven (7) pages printed on one side only, may be submitted by the applicant.
- 5. DO NOT put your name, ARBA number or any headings on your application. Do not use cover sheets.
- 6. If entering online, you may upload you application. If entering by mail, you must include your Contest Entry Form and ONE copy of your answers!

#### **CATEGORIES**

Applications will be judged by ARBA District. All sizes of caviaries will be judged together, regardless of number of holes. **Contestants may enter 1 Rabbit and 1 Cavy Division.** National winners will be selected in each division. Winners will be announced at the Youth Banquet at the ARBA National Convention. Contestants need not be present to win.

#### **SCORING CRITERIA**

Applications will be judged on the following criteria: Herd, Housing & Equipment (50 points); Breeding & Production (50 points); Care, Health & Herd Management (50 points); Record Keeping (30 points); Neatness, Clarity & Thoroughness of Answers (20 points). Applications that do not follow the rules listed above will be assessed a penalty of 10 points per infraction, with the exception of late applications which will be assessed a penalty of 20 points for up to one week late and disqualification for later than one week.

# **ENTRY PROCEDURES**

Entry must be made **online** or on the form provided by the ARBA Youth Department. This form is available from your ARBA District Director, the ARBA office, the ARBA Youth Website, and the ARBA Youth Committee. **NO EMAIL ENTRIES WILL BE ACCEPTED.** 

All online entries, including the uploading of completed forms must be completed by 11:59:59 p.m. EST on September 1, 2024. Mailed entries must be postmarked by August 15, 2024 and should be mailed to the ARBA Youth Chairperson.

# ARBA NATIONAL YOUTH CAVY MANAGMENT CONTEST APPLICATION

### PLEASE WRITE/TYPE QUESTIONS PRECEDING YOUR ANSWERS

- 1. When did you join the ARBA and how many consecutive years have you belonged? Explain any lapses in membership.
- 2. List the breed(s) you now raise and how many animals you have in each breed. Why did you choose this (these) breed(s)? Tell what other breed(s) you have raised in the past and why you no longer raise them.
- 3. Describe where your cavies are located: barn, outbuilding, garage, basement, house, etc? How does this location protect your cavies from heat, cold, drafts or pests?
- 4. List or make a table of the number of cages you have and their sizes. Describe what materials they are made of and how constructed, including pans/trays/tubs. Described how your cavies are housed:community or single.
- 5. Other than feed and water equipment, describe or list ALL other equipment you use in the care/management of your cavies.
- 6. Describe the equipment you use to feed and water your cavies and how your feed is stored.
- 7. What type(s) of feed do you give your cavies? Do you give other supplements or anything in addition to their daily feed? If so, why?
- 8. How do you dispose of the manure and waste your cavies generate?
- 9. What do you do daily, weekly, monthly in the care of your cavies? Be specific.
- 10. What measures do you take to prevent parasites (lice, mites, ringworm, etc) or fungus in your caviary?
- 11. Describe any diseases that have affected your production and what you did to control them.
- 12. Describe everything you consider and do when breeding your cavies. Include ages, time of year, breeding pair choices etc.
- 13. Describe everything you do the prepare for farrowing, including care of the mother and young from breeding until weaning? Include your weaning process, age, and any other considerations.
- 14. List or make a table of how many total litters born, total young born and number of young weaned since January 1, 2023. If you had a difference between total young born and totally weaned, can you explain why?
- 15. Explain what you consider when bringing in new stock or bloodlines into your breeding program. What specific characteristics are you looking for?
- 16. What do you do with your surplus animals?
- 17. What types of records do you keep for your breeding program? Why are these particular records important for the success of your breeding program and achieving the goals that you have set?
- 18. Make a table or a list of your expenses and income since January 1, 2023. Explain any big expenditures or profit.
