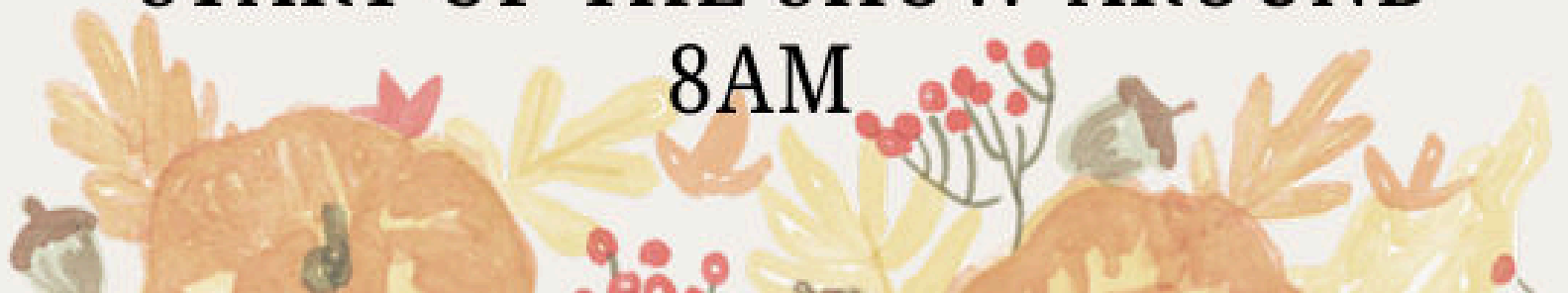

RULES

- 1. THESE SHOWS ARE OFFICIALLY SANCTIONED BY ARBA AND WILL BE GOVERNED BY THE LATEST REVISED RULES OF ARBA. THE FILING OF ANY ENTRY INDICATES UNDERSTANDING AND ACCEPTANCE OF THESE RULES.**

- 2. EXHIBITORS MUST BE CHECKED IN AND THE SHOW SECRETARIES MUST RECEIVE ALL ENTRY FEES BY 8:00AM DAY OF SHOW.**

- 3. ANY CHANGES IN ENTRY MUST BE MADE BEFORE 8:00AM DAY OF SHOW. SUBSTITUTIONS ARE LIMITED: MUST BE SAME BREED, CLASS, SEX, AND OR VARIETY, EAR # CHANGES ONLY.**

- 4. ANY ENTRY NOT CANCELLED WITHIN 24 HOURS OF SHOW WILL BE CHARGED FOR THE ENTRY AND WILL BE BILLED. ANYONE NOT PAYING ENTRY FEE WILL NOT BE ABLE TO SHOW UNTIL BILL IS PAID.**

- 5. ALL RETURNED CHECKS WILL BE CHARGED A 25.00 RETURN FEE AND EXHIBITOR WILL NOT BE ALLOWED TO SHOW UNTIL FEES AND CHARGES HAVE BEEN PAID.**

- 6. NFRCSBA RESERVES THE RIGHT TO REFUSE OR REJECT ANY ENTRY.**

- 7. CLASSES WILL BE CALLED THREE TIMES ONLY. FAILURE TO ARRIVE WITH RABBITS IN TIME RESULTS IN A FORFEIT.**

- 8. THE SHOW SUPERINTENDENT SHALL DETERMINE JUDGING ORDER ASSIGNMENTS.**

RULES

9. THE NFRCSA RESERVES THE RIGHT TO ADD AND OR SUBSTITUTE JUDGES AS NECESSARY. DECISIONS WILL BE THE RESPONSIBILITY OF SHOW SUPERINTENDENT.

10. NO ONE WILL BE ALLOWED BEHIND JUDGE'S TABLES EXCEPT JUDGES AND OFFICIAL HELPERS.

11. DECISION OF THE JUDGE WILL BE FINAL. NO PROTEST WILL BE ENTERED UNLESS IT IS MADE IN WRITING WITHIN TWO HOURS AFTER THE BREED HAS BEEN JUDGED AND ACCOMPANIED BY A \$25.00 FEE. IF PROTEST IS DETERMINED TO BE VALID THE FULL \$25.00 WILL BE REFUNDED. PROTESTS ALLOWED PER ARBA SHOW RULES.

VENUE

12. THE CLAY COUNTY FAIRGROUNDS AND THE NFRCSA WILL NOT BE RESPONSIBLE FOR FIRE, THEFT, ACCIDENTAL OR INTENTIONAL DESTRUCTION. REASONABLE PRECAUTIONS WILL BE TAKEN. (ARBA SHOW RULES SECTION 28.

13. ABSOLUTELY NO ALCOHOLIC BEVERAGES ARE PERMITTED. ANY EXHIBITOR NOT COMPLYING WITH THIS RULE WILL FORFEIT ALL ENTRY FEES AND BE ASKED TO LEAVE THE PROPERTY.

14. NO SMOKING OR VAPOR/E-CIGS IN THE SHOWROOM.

ANIMALS

15. THIS IS A CARRYING CAGE SHOW. LEAK PROOF CAGES MUST BE USED—NO EXCEPTIONS.

RULES

- 16. ANY RABBIT SHOWING SIGNS OF DISEASE WILL BE REMOVED FROM SHOWROOM AND ENTRY FEE FORFEITED.**
- 17. EXHIBITORS WILL BE RESPONSIBLE FOR GETTING THEIR RABBITS ON SHOW TABLE.**

18. THE SALE OF RABBITS IS RESTRICTED TO EXHIBITORS IN THIS SHOW AND MUST BE MINIMUM JUNIOR WEIGHT AND AGE FOR THE BREED.

- 19. FOR THE SAFETY AND HEALTH OF YOUR ANIMAL, EXHIBITORS, AND GUESTS, PETS AND OTHER FORMS OF LIVESTOCK ARE NOT ALLOWED IN SHOW ROOM.**
- NOTIFY THE SHOW SUPERINTENDENT IF: YOU ARE DONATING A (HEALTHY) ANIMAL FOR THE RAFFLE; OR 2) YOU REQUIRE THE ASSISTANCE OF A REGISTERED SERVICE ANIMAL. SERVICE ANIMALS MUST BE ON A LEASH AND WITH THE OWNER AT ALL TIMES. ANIMALS CANNOT BE CARRIED. PLAYPENS ARE NOT ALLOWED.**
