# Show Rules

1. Midwest Trailblazers reserves the right to refuse entries from exhibitors placing an entry from any location within the current ARBA RHDv2 guidelines listed at ARBA.net.
2. This is an official ARBA and Missouri State Rabbit Producers, Inc., Sanctioned show and will be governed by the latest show rules. Filing of an entry indicates acceptance of these rules.
3. Show date: April 11, 2026. The show starts promptly at 8:00 am.
4. Ear number changes will be accepted the day of the show, but must be completed by 730am- No changes are to be made at the table.
5. All rabbits must be permanently and legibly earmarked in the left ear.
6. This is a Pre-entry show only. Email entries may be paid via PayPal, Friends and family or paid day of show. If you enter and no show, you are still responsible for the entry even if you are not present. This could affect your entries at further shows.
- 7. Entries by Mail must be postmarked on or before 4-1-26. Mail entries to Becky Marlow, 604 Broadway St, Pleasant Hill, MO 64080**

9. Entry fee \$4.00 a head per show. Fur entries are \$2 per head per show.

11. Please use a separate form/email for Open and Youth entries, and clearly indicate whether it is for Open or Youth. Please provide your complete name, address, and phone number with all entries.

13. All rabbits must be entered in the name of the owner. Youth cannot show the same rabbit in both open and youth shows.
14. Youth MUST put their rabbits on the judging table unless brought by another party and not present. A youth must put the rabbit on the table. An entry can be forfeited if not in compliance.
15. Midwest Trailblazers is not responsible for any loss from fire, theft, accidents, death of a rabbit, or providential destruction during the show.
16. Unruly children will not be tolerated. Unruly children and parents will be asked to leave and forfeit entry fees.
17. The club reserves the right to add or substitute other judges.
18. Any animal showing signs or symptoms of disease will be removed from the showroom immediately.
19. Show reports will be emailed to each exhibitor within 30 days. Please make sure your name, address, phone number, and email address are legible and correct. No awards will be mailed.
20. Midwest Trailblazers will sanction any breed of rabbit recognized by the ARBA for 2027 if 10 or more are shown in 2026. If 10 or more are not shown in 2025 the sanction will be dropped the following year.
21. Vendors must have permission prior to March 28<sup>th</sup> from the Show Superintendent or Show Secretary to set up sales and must pay a \$50.00 fee or donate an equivalent amount in merchandise for the raffle.
22. Please check in at the office upon arrival to verify all entries.
23. The showroom will be open Friday night until 8:00 pm. Doors will be locked at 8 pm.
