## **Show Rules & Important Information**

This is an ARBA, ASRBA, and MSRPA sanctioned show and will be governed by the latest ARBA and ASRBA show rules. Filing of an entry indicates acceptance of these rules.

The judging order will be set by the superintendent. CSSC reserves the right to add or change judges as they see fit.

A \$30.00 surcharge will be assessed for a check returned unpaid. Entries will not be allowed until the check and surcharge is paid. PayPal will also be used.

All exhibitors (open and youth) must check in with the show secretary by 9 pm April 11, 2025. Otherwise, the entry will be pulled in belief exhibitor is not present.

Owners are responsible for getting their own rabbits to the show table. Carriers are not provided.

Cave State Satin Club nor the Missouri State Fair Grounds will be responsible for any injury or accident occurring during the show. Please understand the below Missouri law before entering, it is also posted in the show room.

Parents are responsible for damage done by their children, please keep track of them.

Equipment and Sales Displays must have permission from the show superintendent to set up. There will be a charge of \$75.00, plus \$10.00 per table rented. Please contact the show committee. Deadline is April 1st, 2025 .

Any animal showing signs of illness or disease will be removed from the showroom. "Show superintendent reserves the right to refuse entries from exhibitors placing an entry from all locations within 25 miles which has had a confirmed outbreak of RCV/RHD/VHD within the past 30 days of the entry deadline.

Due to limited space all rabbits in the show room must be entered. No animals will be allowed on the fairgrounds not entered in show. Grooming tables and chairs should not block isles. This show does not allow animals under ARBA minimum breed weight in the show barn.

Interpretation of the show rules will be by the show officials.
