Show Rules

ENTRIES ARE PRE-ENTRY ONLY. Only changes allowed in the showroom are tattoo changes, the entry must remain same breed/sex/variety/class. Tattoo changes must be completed with the showroom secretary or assistants. ANY CHANGES MADE AT THE JUDGING TABLE WILL BE DISQUALIFIED. TATTOO CHANGES MUST HAVE TATTOO CHANGE SLIP COMPLETED FOR EACH SHOW. No comment cards are used. We suggest bringing a copy of your check -in sheet to record your placements.

ALL ENTRIES MUST BE PAID PRIOR TO JUDGING, ANY ENTRIES NOT PAID WILL BE SCRATCHED FROM THE SHOW. Those exhibitors who continue to enter shows and continue to NO SHOW will be responsible for payments for entry fees. After the 3rd no show of any of the Portage County Rabbit and Cavy Breeders Association, you will be contacted for payment of your entries. We reserve the right to refuse your future entries if no payment is made for entries made.

Forms of payment accepted: cash, check, Zelle, PayPal, Venmo. Credit Cards will have a 3% service charge added for total.

Returned Checks will be charged **\$60.00.** No check will be accepted at future shows from the offender. If entry fee and returned check fee is not paid, then entry to future Portage County RCBA shows will not be accepted until all monies are collected.

<u>Rabbits must be placed on the show table promptly</u> after the breed has been called to the table. DO NOT WAIT FOR YOUR NAME TO BE CALLED. **IT IS THE REPSONSIBILITY OF THE EXHIBITOR TO MONITOR THE SHOW TABLES FOR THEIR BREED AND CLASS.** A class will be called 3 times then it will be close. Any rabbits not placed on the table will be considered a SCRATCH and NO refunds are given. We have signage to aid in identifying location of judging tables.

Interfering with, annoying, or influencing the judges and/or acting in a manner unbecoming will not be tolerated and will result in ejection from the showroom.

Youth entries should be placed on and removed from the table by a youth (between 5-18) unless it is a safety issue for the rabbit and/or youth. It is assumed that a youth owns the animal, and it is not owned by an adult.

Animals must be shown in breed class to be shown in fur class, they cannot compete in the fur class if they were disqualified in the breed class.

The show is governed by the latest ARBA Standard of Perfection and show rules by filing an entry indicates acceptance of our show rules. The show officials reserve the right to add/remove/substituted judges as deemed necessary.

Diseased stock will be required to leave the showroom and the entry fee forfeited. We will refuse entries from areas from the locations within 50 miles of a confirmed outbreak of RCV/RHD/VHD within the past 30 days of the entry deadline. Exhibitors, judges, registrars, transporters and vendors residing in or traveling by vehicle through an area of the country that is part of an active RHD outbreak are discouraged from attending.

No dogs, with the exception of SERVICE DOGS will be permitted in the showroom, unless crated with prior approval are permitted. If the crated animal creates disruption in the showroom it will be required to leave the showroom. Excessive barking of a dog constitutes disruption and will need to be removed.

No sales of rabbits or cavy in the showroom will be allowed by anyone not showing/entered rabbits or cavy.

No crockpot or hot plates are permitted in the building.

ALL CARRIERS MUST HAVE BOTTOMS TO BE IN THE SHOWROOM

No club will hold a meeting during the show that will result in suspending the judging of the show in any way.

Portage County Rabbit and Cavy Breeders Association and its members are not responsible for the loss in the event of fire, theft, or vandalism, nor is it responsible for the exposure to COVID or RHDV. Attendees participate at their own risk.

Judging will begin as close to the listed start times as possible. There may be a need to delay the start of the show due to traffic, construction or unforeseen delays.
