Just for Fun Rabbit and Cavy Club is excited to offer Easy2Show program for our exhibitors. Our show will not accept day of show entries. No comment cards will be used in order to reduce personal contact between people. Please feel free to record comments on your own.

To use the system create an account with https://www.easy2show.com/ You can make one account per family.

Payment will take place upon checking in at the show. **Entries** are \$4.00per animal and \$2.00 per fur entry.

Showmanship Competition Entry

- All showmanship entries MUST be emailed by August 14, 2025 at 9:00pm.

 - Please send NAME, AGE, and if you will be doing Rabbit or Cavy (or both) showmanship.
- \$4.00 Entry Fee per showmanship
 - All proceeds will go to the Branch County Fair Small Animal Program
- Michigan State 4-H Rabbit and Cavy Showmanship guide will be the guidance of the judging.
- Age brackets will be divided up after entries.

Show Rules (General)

- 1. This show will conform to all ARBA show rules.
- 2. There will be no alcoholic beverages allowed at the showgrounds.
- 3. All children are solely the responsibility of the guardian in attendance.
- 4.. Exhibitors will be responsible for any damages they cause to the show facilities.
- 5.. Chairs and grooming tables in designated areas only and only as space permits.
- 6.. There will be a Food Truck onsite.
- 7. A registrar will be available to register your rabbits/ cavies.
- 8. All attendees are required to comply with facility rules, JFFRCC show rules, JFFRCC Issue Resolution Policy, ARBA show rules, and local laws and regulations. All decisions and interpretations of the show committee are final and binding and are made in the best interest of the attendees and overall event. Show officials will be treated with respect both at the show and on social media.
- 9. All animals entered in the youth competitions must be presented to the table by a youth exhibitor. No adult may exhibit for the youth.

Show Rules (Show)

- 1. All exhibitors must be checked in by the designated time in the show catalog.
- 2. Carriers must have a leak proof bottom.
- 3. No remark cards will be used.
- 4. Pleaser review the schedule for entering rabbits online. Exhibitors are solely responsible for getting entries in at the designated time. No exceptions will be made for those who try to enter and the deadline passes during the process.
- 6. Rabbit and all cavy judging will begin promptly at 9:00 AM on Saturday.
- 7. The show committee will announce the respected breeds being judged one time. There will be only one additional call made for any missing rabbits in the breed with a 90 second wait time before the judge will be instructed to move on. Please listen.
- 8. Exhibitors of a breed are responsible for finding a writer for their breed. If writers are not found we will go on to the next breed.
- 9. JFF may change showing order and judges at any time during the show.
- 10. This show will be sanctioned with MSRBA, MSRBYA, ARBA, and all published breeds. .
- 11. JFF reserves the right to make changes to the show at any time as deemed necessary by the Show Superintendent or Show Committee.
- 12. No ribbons for class placings will be available.t. There will be respected awards for Best of Breed and Best Opposite of Breed for the top 15 rabbit and 3 cavy breeds by count. All other breeds with a minimum of 5 rabbits will receive a rosette.
- 13. Any animal presented with disease will be removed from the showroom.

Show Rules (Entries)

- 1. Youth may NOT enter the same rabbit in Open and Youth JFFRCC Shows
- 2. Make checks payable to Just for Fun.
- 3. Post-dated checks will not be accepted.
- 4. Returned checks will be processed and submitted by JFFRCC's bank resubmission services at the expense of the exhibitor (bank will automatically charge the exhibitor's account the state regulated NSF collections fees for each attempted re-submission). JFFRCC will also charge a \$50 administrative fee to the exhibitor. The exhibitor has 10 days upon notice to make good on the bad check and associated fees (only certified bank check or money order will be accepted). If the exhibitor fails to make good within 10 days including associated fees, the exhibitor will be removed from all show reports and eliminated from the show (cannot be reversed once removed). An additional monthly charge of \$5 will be assessed until the exhibitor has fully resolved the issue. Unresolved issues will be prosecuted.
- 6. Payment will be collected during check-in of the show.
- 7. Exhibitors have until the entry deadline to remove any scratches from their entry. After that time scratches will be charged at check-in like a normal entry.
- 8. JFFRCC will strictly enforce the denial of any entry from within 100 miles of a deemed RHVD Zone. This includes any spectators, judges, or exhibitors. Any known person to bring in an animal for transport from the infected radius will be banned from all JFFRCC current and future shows.
