## **Entry Information:**

**Entry fees** - \$5.00 per rabbit, due by 7pm at show for Friday or 8am at the show for Saturday (see right column for online payment options) **Best Junior** – \$5.00 early or day of show. 50/50 cash pay back.

**Entries are due – 8pm Tuesday, January 28th.**

**Late entries** (accepted until 8pm Wednesday, January 29th) \$6.00 per rabbit.

**Day-of-show entries** - \$8.00 per rabbit per show before 7:30 am on Saturday morning for Saturday show.

**Changes** accepted until NOON Thursday, January 30th (after 12:01 pm, only ear number changes are accepted with \$1.00 charge per rabbit, per show. Any change other than ear number will be \$4.00 per rabbit, per show; this includes class (JR, INT, SR) sex (buck/doe) or variety (color class).

**Clean Up Fee** – \$2.00 per family

Check-in sheets will be emailed to exhibitors. It is the responsibility of the exhibitor to check for accuracy of EACH sheet and let the secretary know of any changes. **No changes will be made after judging sheets leave the secretary for the judge's tables!**

Friday early check in and drop off starts at 4:30pm until 9pm. The showroom opens Saturday at 7am.

**Friday show:** check-in is from 5:00pm – 6:30pm, and the show begins promptly at 7pm. **Saturday show:** check-in starts at 7am Saturday (or check in Friday night, after 6:pm), and the show begins promptly at 8:30am. Please be on time.

Check your check in sheets closely to avoid change fees!

**Cancellation deadline** – NOON Thursday, January 30th, *after that time exhibitors will still be responsible for entry fees. Entries not cancelled by NOON Thursday will be sent a bill for the entries.*

## **OFFICIAL SHOW RULES**

### **Show**

1. These shows are officially sanctioned by ARBA and will be governed by the latest revised rules of ARBA. The filing of any entry indicates understanding and acceptance of these rules.
2. Exhibitors must be checked in and the show secretaries must receive all entry fees by 8:00am day of show.
3. Any changes in entry must be made before 8:00am day of show. Substitutions are limited: must be same breed, class, sex, and or variety, ear # changes only.
4. Any entry not cancelled within 24 hours of show will be charged for the entry and will be billed. Anyone not paying entry fee will not be able to show until bill is paid.
5. All returned checks will be charged a 25.00 return fee and exhibitor will not be allowed to show until fees and charges have been paid.
6. NFRCA reserves the right to refuse or reject any entry.
7. CLASSES WILL BE CALLED THREE TIMES ONLY. Failure to arrive with rabbits in time results in a forfeit.
8. The Show Superintendent shall determine judging order assignments.
9. The NFRCA reserves the right to add and or substitute judges as necessary. Decisions will be the responsibility of Show Superintendent.
10. No one will be allowed behind judge's tables except judges and official helpers.
11. Decision of the judge will be final. No protest will be entered unless it is made in writing within two hours after the breed has been judged and accompanied by a \$25.00 fee. If protest is determined to be valid the full \$25.00 will be refunded. Protests allowed per ARBA show rules.

### **Venue**

12. The Clay County Fairgrounds and the NFRCA will NOT be responsible for fire, theft, accidental or intentional destruction. Reasonable precautions will be taken. (ARBA show rules section 28.

13. ABSOLUTELY NO alcoholic beverages are permitted. Any exhibitor not complying with this rule will forfeit all entry fees and be asked to leave the property.
14. No smoking or vapor/eCigs in the showroom.

### **Animals**

15. This is a carrying cage show. Leak proof cages MUST BE USED—NO EXCEPTIONS.
16. Any rabbit showing signs of disease will be removed from showroom and entry fee forfeited.
17. Exhibitors will be responsible for getting their rabbits on show table.
18. The sale of rabbits is restricted to exhibitors in this show and must be minimum junior weight and age for the breed.
19. For the safety and health of your animal, exhibitors, and guests, PETS AND OTHER FORMS OF LIVESTOCK ARE NOT ALLOWED IN SHOW ROOM. Notify the Show Superintendent if: you are donating a (healthy) animal for the raffle; or 2) you require the assistance of a registered service animal. Service animals MUST BE ON A LEASH AND WITH THE OWNER AT ALL TIMES. Animals cannot be carried. Playpens are not allowed.

### **Youth**

20. Youth must be able to handle their own rabbits and bring them to the show table. If youth is not able to bring entry to table, make arrangements in advance with Show Superintendent.
21. Parents will be responsible for their children and their conduct.

### **ARBA SECTION 52.**

Youth exhibitors between the ages of five (5) and eighteen (18) years may enter sanctioned youth shows. Adults cannot show in youth classes at any time. Youth exhibitors must be able to handle their own animals and must be able to place rabbits on the show tables. Youth exhibitors are not required to transport their animals to the table.
