### SWMHR Show Rules

1. This is an official ARBA and Missouri State Rabbit Producers Inc. sanctioned shows and will be governed by the latest show rules. Filing of an entry indicates acceptance of these rules.
2. Show **Date: Feb. 22, 2025 SHOW STARTS PROMPTLY AT 8:30 A.M.**
3. All rabbits must be permanently and legibly ear marked.
4. **This is a PRE ENTRY SHOW. EMAILED ENTRIES MUST BE PAID THROUGH PAYPAL OR VENMO IF EMAILED. SNAIL MAILED ENTRIES MUST INCLUDE PAYMENT. NO ENTRY WILL BE PROCESSED WITH OUT PAYMENT.**
5. Please use a separate form for Open and Youth entries and mark O or Y and if you are showing in one or both shows.

### **THIS IS A NO COMMENT CARD SHOW**

6. All rabbits must be entered in the name of the bonafied owner. Youth can not show the same rabbit in both open and youth shows.
7. **YOUTH MUST PUT THEIR RABBITS ON THE JUDGING TABLE UNLESS BROUGHT BY ANOTHER PARTY & NOT PRESENT.**
8. Southwest Missouri Hare Raisers is not responsible for any loss from fire, thefts, accidents, death of rabbit or providential destruction during the show.  
**UNRULY CHILDREN WILL NOT BE TOLERATED. UNRULY CHILDREN AND PARENTS WILL BE ASKED TO LEAVE AND FORFEIT ENTRY FEES.**
9. The club reserves the right to add or substitute other judges.

10. Any animal showing signs or symptoms of disease will be removed from the showroom promptly.
11. Show reports will be mailed to each exhibitor after the show and within the ARBA allotted 30 days. Please make sure name, address and e-mail address is legible and correct.
12. SWMHR will sanction any breed of rabbit recognized by the ARBA for 2025 if 10 or more are shown in 2024. If 10 or more are not shown in any breed, the sanction will be dropped the following year.
13. Vendors must have permission from the superintendent to set up sales and must pay a fee of \$25.00 or equivalent in merchandise for the raffle. This is a carrying cage show. Leak proof carriers will be required.
14. Any returned check for any reason is subject to a \$50 fee.
