RABBIT AND CAVY SHOW RULES:

- ☐ This show will be governed by the latest ARBA Show Rules. Filing entries indicates acceptance of our show rules. Exhibitors are responsible for checking entries for errors and making changes BEFORE judging begins.**
- ☐ Entry fees must be paid in full. Exhibitors are responsible for all exhibitor fees.**
- ☐ Entry fees are \$4 per rabbit per show and \$2 per fur per show.**
- ☐ The Show Staff has the right to refuse entries from any exhibitor for due cause.**
- ☐ Neither the Springfield Rabbit Breeders Association, Macon County Fair Association nor the venue will be responsible for loss in case of fire, theft, or accident. All precautions will be taken for a safe show. All entries are entered and shown at the risk of the owners and while the Springfield Rabbit Breeders are expected to exercise all reasonable care in the handling and protection of the exhibits, such associations will in no case be liable.**
- ☐ Springfield Rabbit Breeders Association reserves the right to add, change, or substitute judges as the need may arise.**
- ☐ Any exhibitor indicating ownership, harassing, or interfering with a judge (or a writer) will be disqualified and forfeit all fees and winnings. No exhibitor will be allowed behind the judging tables, unless acting in an official capacity, which must be approved by the show superintendent or show secretary.**
- ☐ Any disrespect, arguing or harassment of show staff or other exhibitors will not be tolerated and will lead to the offending party's entry being forfeited and the offending party will be required to leave the venue and will give up any rights to refunds, show reports, and awards and potential exclusion from future events.**
- ☐ Saturday shows start at 9:00 a.m. Please be on time.**
- ☐ Rabbits must be in leakproof carriers/cages.**
- ☐ Show management are compelled to refuse entry to show room and to remove from the same, all diseased or unsightly animals. All entry fees on such animals shall be forfeited.**
- ☐ This is a no comment card show – we will be using control sheets only at the judge's table.**
- ☐ No dogs are allowed in the showroom without permission; Working Service Dogs will be admitted. If you see an animal in the building, other than rabbits or cavies, it's best to speak with the superintendent or secretary first.**
- ☐ NO CHANGES MAY BE MADE AT THE JUDGING TABLES other than those approved by the show secretary. Unapproved changes may result in your animal being disqualified by the secretary after the show.**

- Once a show starts, no changes will be made to the paperwork. ARBA Show Rules, Section 23 ... “No substitutions, changes, or additions will be allowed in a breed after judging of the breed has commenced.”
- No sales of any rabbits or cavies will be allowed by anyone not showing rabbits or cavies. Any exhibitor wishing to sell anything other than rabbits or cavies must pay a vendor fee and must receive permission BEFORE the show. No product pre-sales or pre-orders or deliveries may be made at the show site without permission - in the building or on the grounds.
