OFFICIAL SHOW RULES

1. These shows are officially sanctioned by ARBA and will be governed by the latest revised rules of ARBA. The filing of any entry indicates understanding and acceptance of these rules.
2. The MDRBA, the show grounds, and their representatives will NOT be responsible for fire, theft, accidental or providential destruction. Every precaution will be taken to avoid mishaps. (ARBA show rules section 24.)
3. Exhibitors must be checked in and the show secretaries must receive all entry fees by 8:00 am day of show.
4. The MDRBA reserves the right to add and or substitute judges as necessary. Decisions will be the responsibility of Show Superintendent.
5. This is a carrying cage show. **Leak proof cages** must be used.
6. Any rabbit showing signs of disease will be removed from showroom and entry fee forfeited.
7. Youth rabbits cannot be co-owned by an adult (includes parent and/or guardian). Youth rabbits must be placed on the table by **youth**.
8. Parents will be responsible for their own children and conduct.
9. **ABSOLUTELY NO** alcoholic beverages or illegal substances are permitted. Any exhibitor not complying with this rule will forfeit all entry fees and be asked to leave the property.
10. **NO SMOKING** in showroom or building.
11. MDRBA reserves the right to **refuse or reject any entry**.
12. **The sale of rabbits is restricted to exhibitors in this show** and must be at least 8 weeks old and minimum Jr weight of breed.
13. **No other animals will be allowed in show room except for raffle rabbits or approved by Superintendent.**
14. **Anyone indicating ownership of rabbits on the judging table, harassing, interfering with, or attempting to influence the judges will be disqualified and winnings forfeited. This includes youth entry if parents are the offender.**
15. **CLASSES WILL BE CALLED ONLY THREE TIMES**
16. Exhibitors will be responsible for getting their own rabbits on show table.
17. The show superintendent shall determine judging order assignments.
18. **No one will be allowed behind judges table except judge and official helper.**
19. Decision of the judge will be final. No protest will be entered unless it is made in writing within two hours after the breed has been judged and accompanied by a \$25.00 fee. If protest is sustained the full \$25.00 will be refunded. Protest allowed per ARBA show rules.
