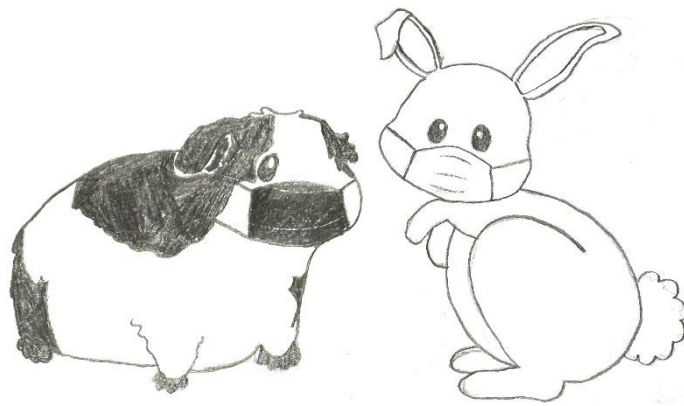

General Show Rules

1. The PPPRCBA Committee reserves the right to restrict show entries due to RHDV2 limitations
2. This is an official ARBA sanctioned show and is governed by the latest rules as such
3. Any animal showing signs of sickness or disease will be removed from the show room at the discretion of the Superintendents and entry fee will be forfeited
4. The superintendents reserves the right to substitute judges if necessary
5. All rabbits must have a permanent and legible earmark
6. Judging will conducted by private ear number
7. Exhibitors will be responsible for carrying their own rabbits to and from the judging table
8. **To avoid delays – the three call rule will apply... at the judge’s discretion.**
9. Neither Fingerlakes Mall (Event Center) or PPPRCBA will not be responsible in case of fire, theft, accident or providential destruction, however, precautions will be taken to reduce any risks
10. Children must be supervised at all times
11. No exhibitor or spectator will be permitted behind the show tables while judging is being conducted, without prior approval of the Superintendent and Show Secretary
12. The showroom will be open at 6 AM
13. All entries must be in the showroom by 7:30AM. **All Breed judging will start promptly at 8AM.**
14. Exhibitors must pick up check-in sheets and verify entry
15. NO CHANGES DONE AT JUDGES TABLE unless approved by show secretary
16. This is a carrying cage show. All carriers must have leak proof bottoms
17. Grooming tables, chairs, and blowers will only be allowed in the showroom if there is room
18. ABSOLUTELY NO dogs, cats, or animals other than rabbits will be allowed in the showroom
19. Anyone causing a disturbance or trying to intimidate a judge will be asked to leave and their entry fee will be forfeited
20. There will be No Breeding Allowed in the Showroom
21. **Remark cards WILL NOT be prepared or provided.** If you’d like to use remark cards for your entry you must bring your own and fill them out for the writers.
22. PayPal is available and the preferred method of payment prior to the show. All payments sent via PayPal are to be sent via the “Family and Friends” route and should include the exhibitors’ names in the note to aid with the secretary work. PayPal address is JennBurrNY@gmail.com
23. Checks are to be made out to Pandemic Palooza Pals Rabbit and Cavy Breeders Association
24. All returned checks will be charged a \$25.00 fee the first and second time they are deposited
25. All show reports will be sent to exhibitor via e-mail (when applicable).

RHV/VHD/RCV Show Rules

1. The Show will follow all guidance put out by the ARBA
2. No entries will be taken from anywhere within 150 miles from an outbreak
3. **DO NOT** use hay or shavings as bedding in carry cages (this is a new recommendation from ARBA to reduce the spreads of RHV/VHD/RCV)
