## **Lodging Recommendations:**

Hutchinson will be hosting the NJCAA tournament starting March 22nd. Recommend checking into lodging in McPherson or Sterling KS. There is some hotel space available in Hutchinson.

The State Fair RV park is open year round for all RV campers to use. For information, contact our staff at 620-669-3600.

Rates: If you would like to stay in our RV Park other than the month of September when the Kansas State Fair is taking place, our rates are as follows: \$30/per night or \$180 per week. Rates are subject to change and rates can vary depending on events going on at the Fairgrounds Again rates are subject to change and rates can vary depending on events going on at the Fairgrounds year-round.

**Entrance**: Entrance to the Kansas State Fairgrounds RV Park, outside of the annual State Fair, can always be attained through Gate 1 located at 2000 N. Poplar St, Hutchinson, KS 67502. Upon entering the Fairgrounds at 20th Avenue and Poplar Street, veer slightly left and go north on Ft Leavenworth Boulevard. You will proceed through the Fairgrounds and enter into the RV Park at the far north end of the Fairgrounds.

**Payments:** Payment can be made at the RV Park payment drop box located at the entrance to the RV Park or at the Kansas State Fair Administration Office. All credit card transactions are subject to a 3% processing fee.

**Contact us:** Throughout the year, the Kansas State Fairgrounds will host several RV rallies. Because of this, it is a good idea to call **620-669-3600** or email and make sure a spot will be available when you arrive. For directions or questions after hours, please call 620-669-3630.

#### **SHOW RULES:**

- 1. This is an ARBA sanctioned show and will be governed by the latest ARBA show rules. Filing of an entry indicates acceptance of these rules. Interpretation of the show rules will be by the show officials.
- 2. DAY OF SHOW ENTRY: \$4.00 per animal Open/Youth shows. Make checks payable to Salt City RBA. A \$35.00 surcharge will be assessed for a check returned unpaid. Until the check is paid, exhibitors will not be allowed to enter any further Salt City shows nor be granted their sweepstakes points.
- 3. Day of show entry. No changes allowed with show secretary approval once show starts.
- 4. Entry consists of entry sheet and comment cards. Remember the same rabbit cannot be entered in both the Youth and Open Shows. YOUTH & OPEN ENTRIES MUST BE ENTERED SEPARATELY. All rabbits must be entered in the name of the bona fide owner. All fur entries must be entered in the regular class.
- 5. ALL CHANGES MUST BE MADE ON THE ENTRY FORM PRIOR TO JUDGING WITH THE OFFICIAL SHOW SECRETARY CHANGES AT THE TABLE ARE NOT VALID. Per Section 23 of the ARBA Official Show Rules: "...No substitutions, changes, or additions will be allowed in a breed after judging if the breed has commenced." The rabbit entered must match the control sheet if they do not match, the rabbit/cavy may be given a "no place" award.
- 6. Owners are responsible for getting their own rabbits to the show table. Carriers are not provided. ALL RABBITS ENTERED IN THE YOUTH DIVISION MUST BE CARRIED TO THE SHOWTABLE BY A YOUTH. YOUTH ENTRIES HANDLED BY AN ADULT WILL BE TRANSFERRED TO THE OPEN DIVISION. ADULTS MAY ASSIST REMOVAL ONLY and extenuating circumstances.
- 7. All rabbits must be permanently and legibly ear marked or they may be disqualified from competition.
- 8. Any animal showing signs of illness or disease and/or unsightly specimens must be removed from the showroom. Entry fees on such specimens will be forfeited.
- 9.Neither the Salt City RBA or the Kansas State Fair Grounds will be responsible for any injury or accident occurring during the show. Please understand the below Kansas law before entering, it is also posted in the show room. KS LAW K.S.A. 60-4001 THROUGH 60-4004 UNDER KANSAS LAW, THERE IS NO LIABILITY FOR AN INJURY TO OR DEATH OF A PARTICIPANT IN DOMESTIC ANIMAL ACTIVITIES RESULTING FROM THE INHERENT RISKS OF DOMESTIC ANIMAL ACTIVITIES, PURSUANT TO SECTIONS 1 THROUGH 4 YOU ARE ASSUMING THE RISK OF PARTICIPATING IN THIS DOMESTIC ANIMAL ACTIVITY.
- 10. EXHIBITORS ARE RESPONSIBLE AND EXPECTED TO CLEAN UP THEIR AREA BEFORE LEAVING. Parents are responsible for damage done by their children, please keep track of them. Attendees should not enter any other building on the Kansas State Fair Grounds unless you are privy to attend the private event. We will do all within our power to have a safe show, please do the same.
- 11. Salt City RBA reserves the right to substitute or add a judge or judges if necessary.
- 12. Grooming tables wagons/carts and chairs MUST NOT block isles and walkways.
- 13. Wool Breeds are asked to groom outside if possible or in the poultry barn
- 14. No Rideable toys allowed in the building.
