These shows will follow all ARBA Show Rules. **ARBA guidelines regarding RHD will be enforced.** All animals must be permanently and legibly earmarked according to ARBA rules. Animals showing signs of disease will be removed from the showroom with the entry fee forfeited. It is the responsibility of each exhibitor to get his or her animals to the judging table.

\*\*\* NO CHAIRS OR GROOMING TABLES WILL BE ALLOWED IN OR BETWEEN THE RABBIT AISLES.

\*\*\* NO BLOW DRYERS will be allowed inside the building. NO SMOKING will be allowed inside the building. Any exhibitor attempting to interfere with, annoy or influence a judge may be ejected from the show. The Show Officials reserve the right to add or substitute judges, assign breeds and make judging order.

**NCRBA and Montgomery County Ag. Assoc. will not be responsible for fire, theft, injury, accident, or providential loss, but every precaution will be taken.**

In accordance with ARBA show rules, anyone who made E-mail Entries and who is a No Show can be charged a Service Fee to cover the Club’s time and expense involved in doing the paper work for the rabbits and then having to scratch them from the paperwork the day of the show. Our Service fee is \$3 per rabbit per show. Entries received after 11:59 pm EST on Tuesday, May 5<sup>th</sup> will be considered a Day of Show entry.

**All Day of Show Entries Must Be Made At the Show Secretary’s Table. There will be a \$1.00 fee per rabbit for Ear Number Changes Day of Show. There will be a \$8.00 fee per rabbit for Any Other Changes Day of Show. There will be No Refunds for Day of Show Scratches or No Shows.** Day of show entries close at 8:30 AM.

**FROM Northern Virginia, Washington, DC Area:** - Take Beltway (I-495) to I-270 North. Go about 11 miles. Exit at Gaithersburg Montgomery Village (Route 124 East / Fairgrounds). Turn right at second light (Route 355 South). Go four stop lights and turn right at Chestnut Street. Turn right into the fairgrounds just before the railroad tracks.

**FROM BALTIMORE, MD AREA-** Take I-95 South to the Inter-County Connector (ICC), MD 200 (West). Go to I-270 North. Exit at Gaithersburg Montgomery Village (Route 124 East). At the second light, turn right on Route 355. Go four stop lights and turn right at Chestnut Street. Turn Right into the Fairgrounds, just before the railroad tracks.
