

General Information & Show Rules

- This show will conform to all current ARBA Show Rules
- The showroom will open at 7:00 am
- No chairs or grooming tables permitted in showroom until after 8:00 am and there must be room for exhibitors and show staff to easily walk around the showroom. Show staff may advise for chairs to be moved – chairs are welcome in the grass outside of the showroom.
- All entries & changes must be in the showroom & checked-in by 8:00 am. The show will begin promptly at 9:00 am.
- All day of show entries for specialties must be completed by 8:00 am. **Specialty shows WILL begin at 8:30 am.**
- There will be no alcoholic beverages permitted on the show grounds (with the exception of raffle basket items, which must remain closed and unconsumed while on show grounds)
- Exhibitors will be responsible for any damages that they may cause. Parents, you are responsible for your children and any damage that they may cause as well.
- Any returned checks are to be paid in full, with an additional \$30.00 bounce fee. Please see rule #9 under show rules regarding non-payment of entries in regards to the handling of show reports and future shows.
- All animals must be in leak proof carriers (this is not a cooped show).
- No dogs or other animals will be allowed in the showroom (with the exception of service animals)
- Smoking is not permitted on the fairgrounds; you may only smoke in the parking lot.
- Delaware Valley Rabbit Breeders Association, Furry Friends Rabbit & Cavy Youth Club, nor the Montgomery County Foundation will be responsible in the case of fire, theft, injury, or providential loss, but every precaution will be taken to prevent these losses.
- **NO PARKING ON GRASS!!!!!! PLEASE UNLOAD AND MOVE TO THE STONE PARKING LOT.**

Showroom:

- Open and Youth will show in Separate Buildings
- Youth Cavies will show in the same building as Youth Rabbits this year
- Tables are provided, but they fill up quickly, so we encourage exhibitors to bring additional tables if you have them.
- We also welcome pop up canopies to be set-up in the grass around the show buildings, but please remember to tie or stake them down 😊
- Drop off at the buildings is allowed but all vehicles must be moved in a timely manner to the stone parking lot to allow others to unload. Driving and Parking on the grass is prohibited.
- Overnight drop off or camping is prohibited.



Show Rules

1. All youth entries must be put on the show table by a youth. Parents may help to ensure there are no injured animals or youth.
2. Any stock showing signs of disease will be removed from the show room and entry fee forfeited.
3. All rabbits and cavies will be judged according to the 2021-2025 edition of the Standard of Perfection.
4. No rabbits under the age of 8 weeks will be allowed in the showroom.
5. All stock must be the property of the exhibitor and must be permanently and clearly tattooed or tagged in the left ear.
6. Please pick up awards during or directly after the show before you leave, no awards will be mailed.
7. It is the exhibitor's responsibility to make sure their animals are at the show table on time- classes will be called three times. If your animal is not on the table, it will be listed as a "no show".
8. All entries are final; no refunds will be given for scratches. You may substitute an animal in the same breed, variety, sex & age class for \$1.00 (TATTOO CHANGE) – as long as this is done by 8:00 am
9. Any exhibitor who has **not** paid for his/her entry and still exhibits the animal(s) will have all entries removed from show reports and will be rejected from showing at future shows until the entry fee is recovered.
10. All judges' decisions will be final.
11. Exhibitors attempting to or actually interfering with judges or show committee or acting in a manner unbecoming of an exhibitor, shall have their stock disqualified and shall be rejected and barred from the show with entry fee forfeited.
12. Youth may show in open and youth but **NOT** with the same animal. (please note they are in separate buildings)
13. Email entries who do not show are still expected to send in their entry fees. Failure to do so will result in entries to future shows being rejected until payment is made.
14. **No changes will be made at the judging tables!** Please check your check in sheets carefully **before the start of the show.** Absolutely no changes will be made after the show starts no matter whose fault the mistake is.
15. Any Exhibitor entered in a Specialty Show must also be entered in at least one of the Furry Friends RCYC/ Delaware Valley RBA Open or Youth all breed shows.
16. **NO pictures of the entry form will be accepted**
17. **ALL EXHIBITORS WILL BE REQUIRED TO SIGN THEIR CHECK IN SHEET FOR THE REGULAR SHOW TO ACKNOWLEDGE THEY CHECKED IT FOR ACCURACY**

RHD Rules

1. The Show will follow all guidance put out by the ARBA & Pa State Mandated Rules
2. The American Rabbit Breeders Association will cancel and reschedule sanctions at no cost to the clubs for show site locations within 50 miles, which had a confirmed outbreak of RCV/RHD/VHD in domestic rabbits within the past 30 days of the entry deadline. A host club must refuse entries from exhibitors placing an entry from all locations within 50 miles, which had a confirmed outbreak of RCV/RHD/VHD in domestic rabbits within the past 30 days of the entry deadline.
3. The American Rabbit Breeders Association will cancel and reschedule sanctions at no cost to the clubs for show site locations within 25 miles, which had a confirmed outbreak of RCV/RHD/VHD in wild / feral rabbits within the past 30 days of the entry deadline. A host club must refuse entries from exhibitors placing an entry from all locations within 25 miles, which had a confirmed outbreak of RCV/RHD/VHD in wild / feral rabbits within the past 30 days of the entry deadline.
4. For assistance in calculating exhibitor distance from a show location in an RHDV confirmed area please contact the ARBA office for assistance since the office will have the correct location to use in the calculation.
5. The ARBA club show committee has the right to refuse an entry.
6. Show officials can designate additional requirements to attend an ARBA sanctioned show.
7. If you are not comfortable, please continue to maintain biosecurity at your residence.

DIRECTIONS TO FAIRGROUNDS

The center is located in the old Skippack Elementary School on Rt. 113, one mile south of Rt. 73 in Skippack.

From Norristown:

Take Ridge Pike west towards Collegeville. Turn right onto Rt. 29 North. Turn right at the next light in Rahns onto Rt. 113. Go approx. 3 miles. The 4-H Center will be on your left.

From Willow Grove:

Take PA Turnpike to Norristown and get on Northeast Extension (476 North). Exit at Lansdale. After going through toll booth, turn right onto Sumneytown Pike. Go approximately 4 miles to intersection of Rt. 113. Make a left onto Rt. 113. Go about 5 miles and you will come to intersection of Rt. 73. Go straight at the light (stay on Rt. 113). It is one mile from that light on the right.

From Philadelphia:

Take 76 West to Valley Forge. Follow signs to Rt. 422 West. Proceed on Rt. 422 to Rt. 29 / Collegeville. Exit on Rt. 29 and go North toward Collegeville. Follow 29N signs (road makes several turns). At light in Rahns, turn right onto Rt. 113. Go approximately 2 miles. 4-H Center will be on the left.

From the North

Take NE Extension of PA Turnpike south to Lansdale exit. After going through toll booth, turn right onto Sumneytown Pike. Go approximately 4 miles to intersection of Rt. 113. Make a left onto Rt. 113. Go about 5 miles and you will come to intersection of Rt. 73. Go straight at the light (stay on Rt. 113). It is one mile from that light on the right.

From Harrisburg

Take PA Turnpike East. Exit at Valley Forge. Follow signs to Rt. 422 West. Proceed on Rt. 422 to Rt. 29 / Collegeville. Exit on Rt. 29 and go North toward Collegeville. Follow 29N signs (road makes several turns). Turn right onto Rt. 113. Go approximately 2 miles. 4-H Center will be on the left.

From the South

Take Rt. 476 North. It becomes the NE Extension of the PA Turnpike (toll road). Take the Lansdale exit. After going through toll booth, turn right onto Sumneytown Pike. Go approximately 4 miles to intersection of Rt. 113. Make a left onto Rt. 113. Go about 5 miles and you will come to intersection of Rt. 73. Go straight at the light (stay on Rt. 113). It is one mile from that light on the right.
