**Show Rules:**

1. This show shall be governed by the latest rules of the American Rabbit Breeders Association and the filing of entries indicates acceptance of these rules.
2. **Eligibility:** All rabbits are eligible to be entered if they are purebred and have a permanent tattoo in their left ear. All cavies will be required to have ARBA approved ear tags in their left ear.
3. All animals must be exhibited in their natural state. Cream rinses cutting of hair, dying, or altering is not permitted.
4. **Entries:** Entries are due by 10:00 PM, Monday, October 6, 2025 - \$5.00. Late entries after 10:00 PM on Wednesday, Oct 8 - \$7.00. No changes except ear #, after 10 pm on Wednesday, Oct. 8<sup>th</sup>. NO entries after October 8<sup>th</sup>- NO Day of show entries.
5. **Entry Fees:** Each Open, Cavy or Youth show - \$5.00 per animal.
6. Scratched entries and “no-show” entries must pay a service fee of \$5.00 per entry.
7. Positively no substitutions will be allowed. Ear number changes for \$1 are the ONLY allowed changes upon check in, Friday and Day of show.
8. **Youth Shows:** Any rabbit entered in Youth Show A will not be able to be shown in Open Show A. All ARBA rules governing the Youth Show will be enforced. All rabbits entered in the Youth Show must be put on the table by a youth. Youth are encouraged to actively participate in the Youth Show by bringing and showing their own animals.
9. All entries must be paid by 8 am EST, the morning of the show. All late entries and all changes must be made by 8am EST. All changes must be made before 8 am.
10. **Parking:** All rabbit exhibitors should enter the Livestock entrance at the East Gate off of Larry Walker Parkway. Gate guards will allow those with rabbits to enter that gate and will direct exhibitors to the Multipurpose Building (where Rabbit show is held). **Please note: The rabbit show is in the Northwest corner of the Multipurpose Building.** After unloading, all vehicles should be parked in the designated exhibitor parking area.
11. **Judging** will begin promptly at 8:30 a.m. Saturday, October 11, 2025.
12. Rabbits and Cavies will be called to the table three (3) times. This will be a carrying cage show, with each breeder responsible for his/ her rabbits
13. The club reserves the right to substitute judge(s) in case the judges listed are unable to officiate. The show superintendent reserves the right to assign judges to each breed.
14. No rabbits under eight (8) weeks of age will be allowed in the show area.
15. Any rabbit or cavy showing signs of disease will be removed from the showroom and the entry fee forfeited.
16. Exhibitors or guardians of exhibitors attempting to, or interfering with, annoying, molesting, or influencing the judge or judges, or acting in a manner unbecoming an exhibitor(s) shall have all of their stock disqualified by the judge and shall be ejected by the show superintendent and barred from the show room. All fees and winnings may be forfeited. Any behavior deemed inappropriate by the GRSCA BOD, in the showroom or on the grounds, may result in expulsion from the facility, scratching of entries without refund, and future penalties based on the severity of the behavior.
17. **Breeding** will not be allowed in the showroom without the consent of the show officials and both owners of the rabbits/cavies.
18. Showroom etiquette is expected. Each parent is accountable for their children’s conduct at the show.
19. Animals are NOT to be carried around the fairgrounds. Bring directly to the showroom from your vehicle and return directly to your vehicle after the show.
20. The Georgia National Fair and the Georgia State Rabbit & Cavy Association will not be responsible for loss in case of fire, theft, accident, or providential destruction. Every precaution will be taken to eliminate danger or mistakes in the showroom.
21. Only current ARBA recognized breeds and varieties, or breeds and varieties with a current Certificate of Development will be allowed to be shown, as per ARBA rules. Please bring a copy of the working standards for the judges.
22. **Sanctioned Breeds:** ONLY O/Y Brit Petite, Youth Dutch, O/Y Flemish Giant, Youth Himalayan, O/Y Holland Lop, O/Y Mini Rex, Open Mini Satin, O/Y Netherland Dwarf, Open New Zeland, Open Rex, Open Satin, O/Y Silver Fox. PLUS a Silver Fox Specialty Show Saturday at 8 AM.
23. All breeds may be shown regardless of being sanctioned or not. Only sanctioned breeds with 10 or more in a breed will receive awards
24. **AWARDS: SHOW “A and B” YOUTH Rabbits** - Awards will be given for all sanctioned rabbit breeds, (with 10 or more entered in the breed) for Best of Breed and Best Opposite Sex of Breed. Plaques will be given to Best in Show and Best Reserve in Show.
25. **There will be an official registrar at the show. You will need your ARBA card and the three (3) generation pedigree for each rabbit you wish to register.**
26. **No Vending of any kind, (No sales, pre-sales, pre-orders or deliveries) may be made at or during the Georgia National Fair without permission! This includes the sale of Rabbits or Cavies**
