Bear River Rabbit Club - Show Rules

1. Entry Fees: \$4.75 per rabbit/per show for pre-entries, \$8 for late & day of show entries per rabbit/per show, \$3 fur per rabbit/per show. All rabbits entered in fur must also be entered in its own breed class.
2. Judging will begin at 9:00 a.m. All rabbits must be in the show room and entry fees paid by 8:30 a.m. day of show. Cash or check only.
3. No refunds once the show has started.
4. All changes must be made by 8:30 a.m. No changes/corrections will be accepted once the show has started.
5. All rabbits entered must have a readable and permanent tattoo in the left ear.
6. This is an ARBA sanctioned show. By the filing of your entry, you indicate your acceptance of all our show rules and the rules of the ARBA which govern this show.
7. All youth entries must be carried to the show table by a youth. Exhibitors do not have to carry their own animals to the show table.
8. Solid bottom carriers only. Exhibitors are responsible for bringing rabbits to the show table as soon as the class is called. Rabbits will be called 3 times. If not on the table after the final call, the class will be closed. There is NO re-judging of a class. ALL judges' decisions are final. Judge interference is not allowed. Problems and/or questions must be taken to the show superintendent.
9. No animals under 8 weeks of age will be allowed in the show room.
10. ANY AND ALL ANIMALS SHOWING SIGNS OF DISEASE SHALL BE REMOVED FROM THE SHOW ROOM.
11. Only service dogs are allowed in the show room. They must be well behaved and wearing their service vest. No exceptions!
12. Only members of the show committee or those asked by the show superintendent to scribe are allowed behind the table.
13. Breed assignment of judges and judging order is the responsibility of the show committee. We cannot adjust judges, judging order, etc. for every request.
14. BRRRC reserves the right to substitute judges in any event.
15. Please keep the area clean. No smoking in the building. No alcoholic beverages allowed.
16. BRRRC, its officers, or the owner, agent, or management of the show facility, or any other related organization will not be held responsible for any type of theft, accident, or personal injury to any person or personal property due to neglect or any other cause.
17. There will be a \$25.00 service charge added to all returned checks. If not paid, you may face collection charges plus the \$25.00 fee.
18. BRRRC reserves the right to refuse entries from any exhibitor for due cause. BRRRC show staff voluntarily put on this show for everyone's enjoyment. Abuse (verbal or physical) towards judges, show staff, or exhibitors will not be tolerated, and you may be served with a Notice of Trespass if you threaten or are a threat to our staff and exhibitors. All entry fees will be forfeit.
19. Children must be supervised by their guardians. Damages by children will be the responsibility of their parents.
