## Check In and Judging

Please bring a copy of your e-mailed entry and AVRCC confirmation of receipt to the check-in table prior to commencement of judging. If you do not receive confirmation of receipt of your entry you have not been successfully entered into this show.

**Check In** will begin at 7:30 AM **Judging** will begin at approximately 8:30 AM

**Ear Changes (entry substitutions)** will be accepted where the Breed and Class of both animals are the same. These substitutions are to be completed with the show secretary, and must be made prior to judging of the class. It will be the exhibitor's responsibility to ensure that correct and legible changes are made. The show secretary or their designate will adjust the control sheet at the judging table. Note that three (3) ear changes will be allowed for no additional fee, after which a \$3.00 fee will be charged for each substitution.

**Class, Sex & Variety changes** may be accepted on the day of the show and will be at the discretion of the show secretary. All of these changes are subject to a \$5.00 fee per show.

## Show Rules

1. This show will be held in strict accordance with the current Official Show Rules of the American Rabbit Breeders Association, Inc.
2. Only Rabbits, Cavies and Service Animals under protection of the American Disabilities Act are allowed in the show room. All others will be removed from the show room.
3. The AVRCC reserves the right to refuse entry to anyone. AVRCC also reserves the right to add or change any Judge.
4. Every precaution will be taken for the safety of the animals entered into the show; however, all rabbits and cavies are entered at the owner's risk. The AVRCC, its officers and the judges are not liable for any injury/death or damage in connection with the show.
5. Aisles must be kept clear for safety. Please be considerate and do not block other exhibitors' spaces and pathways to show tables.
6. **Parents and acting guardians will be responsible for the conduct of their charges. Inappropriate behavior, disrespect of animals, property or persons will result in dismissal from this show and forfeiture of their entry fees.**
7. Entry fees become due once an entry has been received.
8. Any entry changes not made with the show secretary prior to judging of the class will deem that entry "no show" when secretary completes the show reports. It is the exhibitor's responsibility to complete with the show secretary any such changes, prior to judging of the class.
9. All animals must be healthy and in proper size transport cages with appropriate bottoms to ensure the animal's well-being.
10. All entries must be permanently and legibly marked in the left ear prior to showing. An ARBA-licensed registrar will be available.
11. Exhibitors are responsible for ensuring that their entries are taken to the judging area when called & for removing their entries from the judging table as appropriate. No classes will be re-judged for missed presentations of entries. No refund of fees will be made for missed presentations of entries.
12. Exhibitors are prohibited from making comments and/or gestures that might identify ownership of an entry, or might influence the judging of an entry. Entries identified in such a manner will be disqualified and removed from the show.

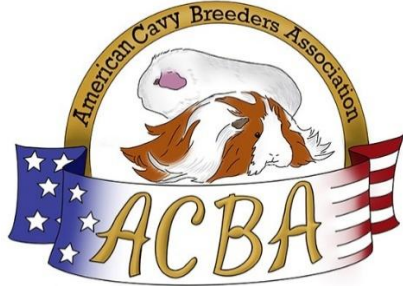
