- 3. THIS IS A PRE-ENTRY SHOW ONLY Entry fee—\$4.00 PER RABBIT. FUR IS \$2 PER RABBIT PER SHOW. Day of show for late entry @ \$ 6 each. Additional rabbits must be entered by 7:15am. Make checks payable to WEST CENTRAL MO YOUTH CLUB (WCMYC). \$25 for returned checks will apply.
- **4.** All rabbits must be entered in the name of the rabbit's owner. Youth cannot show the same rabbit in both open and youth shows.
- 5. YOUTH MUST PUT YOUTH RABBITS ON THE JUDGING TABLE.
