ENTRY INFORMATION

PLEASE DO NOT send your entries via facebook message, text, or by post/comment on the Facebook page. Please make sure to include each exhibitor's name, address, and phone number. Please also state clearly which shows you want each rabbit/cavy entered in. Include Ear Number, Breed, Variety, Class and Sex.

Email entries for Friday and Saturday Open and Youth All-breed shows and Friday specialty shows which are hosted by Rabbit Renegades or Central States Nomads to the address listed on the event page.

BE SURE THAT YOU RECEIVE AN EMAIL CONFIRMATION WITHIN 24 HOURS OF SUBMITTING YOUR ENTRY. If you don't receive one, your entry may not have been received. Please check in with the secretary.

Entry fees may be paid by cash or check at the time of check in. We do not accept credit cards.

CHECK IN AND SHOW TIMES

Friday Show – Judging Starts at 6:30 pm

Friday Check in for All Shows – 3:00 pm – 6:00 pm

Saturday all-breed shows start at 8:00 am

Saturday Check in from 6:00 am – 7:30 am

Building opens at 6:00 AM on Saturday

Rabbits may be left in the Building overnight on Friday night, but MUST be removed upon the conclusion of Saturdays shows.

All-Breed Best In Show Judging:

Best in show rabbits will be chosen at the end of the day after the completion of all shows. If you cannot stay for the conclusion of the last show, please arrange to leave your BOB animals with a friend for the BIS competitions.

SHOW RULES

1. This show will be governed by the latest [ARBA Show Rules](#). Filing of entries indicates acceptance of our show rules. Exhibitors are responsible for checking entries for errors and making changes BEFORE judging begins. Entry fees must be paid in full.
2. Exhibitors are responsible for all exhibitor fees unless a 48 hour cancellation notice was received. Should you enter and not attend, you may be billed for your entry fees. Your mail or email entry is a contract and fees are payable regardless of your attendance. Exhibitors that do not come to the show will be sent a bill and will not be allowed to enter animals in future shows until the bill is paid. Exceptions may be made in the case of emergency or unforeseen illness, as long as the show is notified prior to the show.
3. Neither the Greene County Rabbit Club, Stonebelt RBA or the venue will be responsible for loss in case of fire, theft or accident. All precautions will be taken for a safe show. All entries are entered and shown at the risk of the owners and while the judges and staff are expected to exercise all reasonable care in the handling and protection of the exhibits, such associations will in no case be liable.
4. Greene County RC and Stonebelt RBA reserves the right to add, change, or substitute judges as the need may arise.
5. Any exhibitor indicating ownership, harassing, or interfering with a judge (or a writer) will be disqualified and forfeit all fees and winnings. No exhibitor will be allowed behind the judging tables, unless acting in an official capacity, which must be approved by the show superintendent or show secretary.
6. The show will start promptly at 6:30 pm on Friday and 8:00 a.m. on Saturday local time. Please be on time.
7. Rabbits must be in leakproof carriers/cages.
8. Show management are compelled to refuse entry to show room and to remove from the same, all diseased or unsightly animals. All entry fees on such animals shall be forfeited.
9. This is a no comment card show – we will be using control sheets only at the judges table.
10. No dogs are allowed in the showroom without permission; Working Service Dogs will be admitted. If you see an animal in the building, other than rabbits or cavies, it's best to speak with the superintendent or secretary first.
11. **NO CHANGES MAY BE MADE AT THE JUDGING TABLES other than those approved by the show secretary. Unapproved changes may result in your animal being disqualified by the secretary after the show. Once a show starts, no changes will be made to the paperwork. ARBA Show Rules, Section 23 ... “No substitutions, changes, or additions will be allowed in a breed after judging of the breed has commenced.”**

12. No sales of any rabbits or covies will be allowed by anyone not showing rabbits or covies. Any exhibitor wishing to sell anything other than rabbits or covies must pay a vendor fee and must receive permission BEFORE the show. No product pre-sales or pre-orders or deliveries may be made at the show site without permission - in the building or on the grounds.

13. Per ARBA Show Rules SECTION 30. All animals must be the bonafide property of the exhibitor(s) prior to entry. Rabbits and covies shall not change exhibitors between shows. Youth may change between open and youth, but exhibitors will not be changed, added or removed from the first show entered to the last show.
