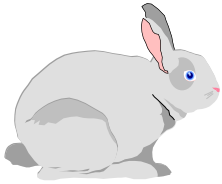

- DISEASED STOCK WILL BE REMOVED FROM SHOW ROOM & ENTRY FEE FORFEITED
- ALL RABBITS & CAVIES MUST BE PERMANENTLY & LEGIBLY EARMARKED
- THE DECISION OF THE JUDGE IS FINAL.
- NO ANIMALS EXCEPT RABBITS AND CAVIES ALLOWED IN THE SHOWROOM.**
- NO BREEDING ALLOWED IN THE SHOW ROOM.
- THE BREEDER IS RESPONSIBLE FOR GETTING THEIR ANIMALS TO THE JUDGING TABLE. IF YOU CANNOT, HELP WILL BE PROVIDED. CLASSES WILL BE CALLED THREE TIMES ONLY. PAY ATTENTION!!!
- YOUTH MUST PUT RABBITS ON SHOW TABLE FOR YOUTH SHOWS.
- SJR&CBA IS NOT RESPONSIBLE FOR WET GRASS OR BEES!!
- YOU MUST PRINT YOUR COMPLETE NAME, ADDRESS, & PHONE NUMBER ON THE ENTRY FORM TO RECEIVE A SHOW REPORT
- SJR&CBA RESERVES THE RIGHT TO REFUSE ENTRIES FROM EXHIBITORS PLACING AN ENTRY FROM ALL LOCATIONS WITHIN 150 MILES WHICH HAS HAD A CONFIRMED OUTBREAK OF RHD/RCV/NHD WITHIN THE PAST 60 DAYS!!
