SHOW RULES

1. This show is to be governed by the latest rules of the ARBA, and filing an entry indicates acceptance of the same.
2. The Miss Sala Bash Rabbit Club & Duneland Rabbit and Cavy Fanciers will not be responsible for loss from Fire, Theft, Accidents or Providential Destruction. Every precaution will be taken to prevent the same.
3. Specials, received too late for listing, will be posted in the showroom.
4. The club reserves the right to substitute another judge, in case of unavailability of the first selection.
5. ENTRY FEE: Single rabbit - \$4.00 per show, Fur/wool entries \$2.00. (OPEN & YOUTH).
6. Fur entries must be labeled if they are to be Breed or General fur class. Fur entries are shown in their BREED class.
7. This will be a carrying case show only. ALL cases MUST BE solid bottomed.
8. ALL animals must be Permanently and LEGIBLY tattooed in the left ear.
9. All rabbits for Open and Youth must be in the showroom by 8:30 am.
10. Any rabbit showing signs of sickness or disease will be denied show space or asked to leave at the discretion of the show superintendents. No breeding is allowed on the premises without consent of the owner/owners and show superintendents.
11. You are responsible for getting your rabbits to the judges table. No adults are to place rabbits on the Youth judging tables. Classes will be called three (3) times only from the judging tables. No entry fees will be refunded.
12. Specials will be paid as required for all SANTIONED breeds with 10 or more in the breed. No class premiums will be paid.
13. No Ribbons will be given this year.
14. An ARBA registrar will be available.
15. No shipped in rabbits will be accepted.
16. We will not use ARBA entry forms and remark cards.
17. Any breed sanctioned this year having fewer than ten (10) rabbits shown may not be sanctioned next year unless a breeder sponsors the sanction fees.
18. All vendors selling items must have the approval of the Miss Sala Bash Rabbit Club prior to setting up in the showroom.
19. The ARBA host club reserves the right to refuse entries from all locations within 150 miles which has a confirmed outbreak of RCD/RHD/VHD within the past 60 days of the entry deadline.
20. The host club is not responsible for catalog errors or omissions.
21. Parents: You are responsible for your children and their actions while visiting the Wabash County Fairgrounds. Therefore, if you child damages property; you are responsible for its replacement.

Miss Sala Bash Rabbit Club will provide a food truck on site.
