- If you have ANY problems or issues concerning the show, please see the Show Super or any of the show committee and we will handle the problem to the best of our ability in compliance with the ARBA and MACBA Show Rules.
- This show is sanctioned by the American Rabbits Breeders Assn. and the American Cavy Breeders Association and will be governed by their latest show rules and standards. Filing of entry indicates acceptance of these rules.
- Judging will be done by private ear number.
- Exhibitors are solely responsible for getting their cavies to the table when their breed/variety is called. Classes will be called a maximum of three (3) times after which judging will resume.
- Cavies showing signs of disease will be removed from the showroom and the entry fee will be forfeited. ONLY cavies permitted in the showroom no other species of animal permitted in OR for sale in the showroom.
- All cavies will be judged by an ARBA licensed cavy judge. All ARBA judges are required to verify permanent ear numbers against coop cards.
- All specials and awards not picked up will become the property of the MACBA.
- The Mid-Atlantic Cavy Breeders Association will not be responsible in case of fire, theft, accident, or provident destruction; however, every precaution will be taken to guard against losses in the showroom.
- The show committee reserves the right to amend or change these rules as necessary, having, at all times, the interest of the exhibitor in mind.
- There will be no changing of classes permitted after entries close.
- There is no smoking in the showroom. No alcohol permitted on premises.
- We would like to remind all those attending the show that no one other than the judge is allowed behind the table while the judging is going on without the express permission of the show superintendent or show secretary according to the ARBA Show Rules.
- There will be a fee of \$25 imposed on anyone wishing to sell cavies in the show room without an entry in any of the shows. Space for these animals will be limited and acceptance of these will be at the discretion of the show superintendent.

There will be a \$20.00 service fee imposed on any checks returned to MACBA for any reason.
