Show Rules

This show is governed by the latest ARBA Standards of Perfection and show rules

- Youth rabbits must be placed on and removed from the show table by themselves. It is assumed that the youth own the animal and not by an adult. Due to safety reasons an adult may assist youth with 6-class rabbits, however the youth must be present and involved.
- No rabbits under 8 weeks of age allowed in the showroom.
- Judging will begin as close to 9am as possible for All Breed Show. Specialties Cavies begin at 8. There may be a need for delay due to traffic, construction, or unforeseen circumstances. Showroom opens at 7am.
- Rabbits must be shown in All Breed class to be shown in Fur class.
- Rabbits must be placed on the table promptly after a breed has been called to the table. DO NOT wait for your name to be called. It is your responsibility to monitor the show tables for your breed and class etc. Any rabbit not placed on the show table will be considered a "scratch" with no refund given. Each breed will only be called twice.
- Interference with judges will not be tolerated. Any exhibitor who is seen doing such (ie. Behind the judges table etc.) will be asked to leave the showroom with no refunds given.
- No Breeding of rabbits in the showroom.
- Any animals showing signs of illness will be removed from the showroom and entry fees forfeited.
- No alcoholic beverages or drugs of any kind on the fairgrounds.
- No dogs apart from SERVICE dogs in the showroom.
- The Washington County RBA, nor the Washington county Agricultural Fair will not be responsible for loss or damage to any exhibit. Every precaution will be taken to ensure the safety of you and your rabbits.
- Youth cannot show the same rabbit in youth and open class in the same show.
- The WCRBA show committee has the right to refuse an entry.
- All Carriers Must Have leakproof bottoms with absorbent material inside them.
- Parents must keep their children under control. You are responsible for any damage they may cause.
- No crock pots or hot plates in the show room.
- Returned checks will be charged a fee of \$40.00 with no checks being allowed for future shows. If the returned check remains unpaid no future entries will be accepted from the household.
- This is a PRE ENTRY SHOW ONLY. All exhibitors must CHECK AND VERIFY entries for accuracy BEFORE and AFTER submitting. No comment cards will be used. If you have any errors or problems, please contact the show secretary Nick Gephart. NO REFUNDS!

- Sales/Vendors: Anyone selling ANYTHING other than rabbits or cavies must be pre-approved by the show committee. This includes but is not limited to crocks, bottles, feeders, carriers, nest boxes, cages, rabbit supplies, food items, miscellaneous items, etc. If you become designated as a vendor, you are required to set up as one and donate to our raffle table. Which will be explained further by show staff. (Note: Pre-sold crocks, bottles, nest boxes and feeders are exempt from this rule.)
- Absolutely no selling of any other animals other than rabbits or cavies in the showroom or on fairgrounds.
- Show Staff/officers reserve the right to remove anyone for any reason from the showroom/ fairgrounds with no refunds on entries.
- Entries that "No Show" without notification prior to the show will be invoiced in the mail by the WCRBA.
- Best in Show For Show A and B will occur at the end of the show
